Sub: Implementation of “*National Education Policy-2020- uploading the admission details on UUCMS portal and Starting of help-desk at the college premises & dedicated helpline*”

Ref: This Office Circular No. BCU/BoS/NEP/ 92/2021-22 Date: 19.08.2021

1. In continuation of the University Circular referred above and pursuant upon the implementation of “*National Education Policy-2020*” (NEP-2020) by the Govt. of Karnataka, the Principals of all the Autonomous/Affiliated Colleges are hereby informed to implement the “*National Education Policy-2020*” from the Academic Year 2021-22.

2. The admission to different courses in all the affiliated colleges have to be done as per NEP 2020 and details are to be uploaded as per the UUCMS portal after obtaining the login credentials through UUCMS portal, E-Governance, Govt. of Karnataka. Till such time the UUCMS portal is ready for online admission, admissions can happen as per the existing system and subsequently the data shall be uploaded on the UUCMS portal.

3. The Principals of the Affiliated / Autonomous Colleges have to ensure establishment of a dedicated help desk at the College premises and also helpline services for the benefit students of general public for necessary clarifications with regard to NEP 2020 .

4. The Colleges have to organize workshops for creating awareness about the NEP 2020 amongst the Management, Faculty, non-teaching staff, students and parents.
